Whereas, the City of Lockport applied for and subsequently awarded a \$50,000 grant from the New State Department of Health (NYSDOH) to improve the Fluoride Feed System at the City of Lockport Water Treatment Plant, and

Whereas, on resolution 081617.6 the Common Council awarded the Fluoride Feed System Replacement project to Hohl Industrial Services, Inc., and

Whereas, the Chief Operator of the Water Treatment Plant requested additional work to fabricate and install a crossover ladder at the opening of the fluoride room and to replace the existing coating behind the fluoride tank, and

Whereas, Hohl Industrial Services, Inc. has submitted a change order for \$7,691.05 to complete the additional work and such change order has been approved by the City's consultant engineering firm Nussbaumer and Clarke, and

Whereas, 2017 Budget needs to be amended to accommodate the cost of the additional work; now, therefore, be it

Resolved, that the Mayor, subject to Corporation Counsel approval, is hereby authorized and directed to sign Hohl Industrial Services, Inc.'s change order to fabricate and install a crossover ladder and to replace the existing coating behind the fluoride tank at the City of Lockport Water Treatment Plant; and, be it further

Resolved, that the 2017 Budget be amended.
