**FILING FEE:** A \$15.00 filing fee must accompany your application. Checks and money orders made out to the City of Lockport Department of Civil Service.

**VACANCIES:** The eligible list established as a result of this examination will be used to fill vacancies as they occur within the City of Lockport Highway and Parks Department.

**SALARY:** \$16.87-\$21.13/hr

**DUTIES:** The work involves responsibility for the construction, installation and repair of traffic signs throughout the city. An employee in this class also assists in the painting or traffic markings on various city streets, crosswalks and parking areas. The work is performed under general supervision. Supervision may be exercised over a small group of laborers and/or municipal workers. Does related work as required.

**MINIMUM QUALS:** One (1) year of experience in sheet metal or sign maintenance work.

**Special Requirement:** Possession of an appropriate level New York State driver's license at the time of appointment.

**SCOPE OF EXAM:** **Understanding and interpreting written material**

These questions test for the ability to understand and interpret written material. You will be presented with brief reading passages and will be asked questions about the passages. You should base your answers to the questions **only** on what is presented in the passages and **not** on what you may happen to know about the topic.

**Pavement marking for traffic control purposes**

These questions test for knowledge of the principles and practices involved in pavement marking for traffic control purposes and may include such areas as types of equipment, procedures, and paints used, and proper legal markings to use to guide and direct vehicular traffic.

**Materials, equipment and methods used in producing traffic and street signs**

These questions test for knowledge of the distinctive characteristics legally required for various types of traffic and street signs and for knowledge of the materials and processes used to produce these signs.

**Placement, positioning and maintenance of traffic control devices**

These questions test for knowledge of the various types of traffic control signs and pavement markings used to guide and direct vehicular traffic and the proper placement and maintenance of such signs and markings.

**Test guide:**

The New York State Department of Civil Service has not prepared a test guide for this examination. **CALCULATORS ARE ALLOWED FOR THIS EXAMINATION**

Candidates are allowed to use quiet, hand-held solar or battery powered calculators. Devices with typewriter keyboards, spell-checkers, personal digital assistants, address books, language translators, dictionaries, or any similar devices are prohibited. Use of books and other reference material is prohibited.
