040120.4 By Alderman XXXX: Whereas, the City of Lockport (City), applied for and has been awarded a grant for a City Streetscape Green Infrastructure Enhancement Project on Pine St., South St. and Washburn St. via the New York Consolidated Funding Application (CFA) to the Green Innovation Grant Program (GIGP); and

Whereas, the City project cost estimate for the Streetscape Green Infrastructure Enhancement Project is \$2,000,000; and

Whereas, the City was awarded a GIGP Grant through NYS Environmental Facilities Corporation (NYSEFC) for \$1,500,000 of the project cost; and

Whereas, the GIGP program requires a **minimum** local match of 10% of the grant amount, which is a **minimum** of \$166,667 for this project; Now, therefore, be it;

RESOLVED that the Mayor is authorized to execute a Grant Agreement with the NYSEFC and any and all other contracts, documents and instruments necessary to bring about the Project and to fulfill the City's obligations under the Green Innovation Grants Program through NYSEFC; and be it further;

RESOLVED that the City authorizes and appropriates a minimum of 10% local match as required by the Green Innovation Grants Program. The source of the local match shall be from the Lockport Downtown Revitalization Initiative (DRI) funds awarded to the City to implement Green Infrastructure in the project area and The Mayor may increase this local match through the use of in-kind services without further approval from the City. Funds in excess of the required match shall be from the DRI and the Community Development Block Grant awarded to the City which included funds to implement Green Infrastructure in the project area.

WHEREAS, Governor Cuomo has declared a State of Emergency for all of New York State in response to the COVID-19 public health crisis; and

WHEREAS, Governor Cuomo has directed that each employer shall reduce the inperson workforce at any work locations by 100% no later than March 22, 2020, which restriction is to continue until April 19, 2020; and

WHEREAS, Section 185 of the City of Lockport Code provides that a 10% penalty shall be added to any water/sewer bill if said bill is not paid within 30 days from the date of issue; and

WHEREAS, due to the public health crisis and Governor Cuomo's directive, numerous City residents are out of work through no fault of their own; and

WHEREAS, the Common Council of the City of Lockport desires to waive the 10% penalty on water/sewer bills due to the City if not paid within 30 days during this period of the public health crisis; NOW, THEREFORE, BE IT

RESOLVED, that the Common Council hereby directs the City Treasurer to waive the 10% late fee on water/sewer bills remaining unpaid after 30 days from the date of issue; and be it further

RESOLVED, that the waiver of the 10% water/sewer bill penalty shall be effective for any water/sewer bill that has a due date of March 30, 2020 and no other previous balance owed; and be it further

RESOLVED, that the water/sewer bill that has a due date of March 30, 2020 will be due on and no later than April 30, 2020 to avoid the 10% late fee and if payment is received later than April 30, 2020, the full penalty shall apply; and be it further

RESOLVED, that the waiver of the 10% water/sewer bill penalty shall be effective for any water/sewer bill that has a due date of April 30, 2020 and no other previous balance owed; and be it further

RESOLVED, that the water/sewer bill that has a due date of April 30, 2020 will be due on and no later than June 1, 2020 to avoid the 10% late fee and if payment is received later than June 1, 2020, the full penalty shall apply; and be it further

RESOLVED, that the Common Council will assess the water/sewer bill 10% late penalty on a monthly basis until the State of Emergency for all of New York State has been rescinded.

WHEREAS, on September 12, 2019, an arbitrator, appointed by the New York State Public Employees Relations Board, ruled that the City violated the Lockport Professional Firefighter's Association Collective Bargaining Agreement by reducing minimum manning per shift from 9 to 6, and

WHEREAS, the City of Lockport appealed the Arbitrator's ruling to Niagara County Supreme Court on December 9, 2019; and

WHEREAS, the City's appeal was denied and petition dismissed by written Order of Supreme Court Justice Frank Caruso on March 6, 2020; and

WHEREAS, the annual reoccurring cost to the taxpayers to add 12 additional firemen to the budget will exceed \$850,000 a year; and

WHEREAS, the Common Council of the City of Lockport desires to appeal the Order of Supreme Court denying the City's Petition to vacate the Arbitrator's decision.

NOW, THEREFORE, BE IT RESOLVED, that the City of Lockport Common Council does hereby request that the Mayor and Corporation Counsel to immediately direct outside counsel, Bryan Goldberger, Esq. to move to appeal the Order issued by Justice Frank Caruso on March 6, 2020 that denied the City's Petition to vacate the Arbitrator's decision.
