Items Discussed: James Gailor, 118 Locust St. Recently purchased the 4 unit building at that location. Mr Gailor requested an on street parking permit for one of the tenants. Lt. Pittman and the Streets Dept. will look over the area and see if there are any issues with granting the request. Of no problems arise, the request will be granted. All In favor.

A letter from Mark Sewar, 161 East Avenue, across from Post Office. This property has Wakeman Alley running through the back. There is increased traffic using the alley for various reasons. Mr. Sewar asked for "Children at Play" signage to be placed. Mr. Hoffman and Lt. Pittman offered the "Slow Down, We Love Our Children" signs be installed. This was unanimously approved.

Parking in the area of 13 Bright St. An unnamed resident asked that someone look at the area to see if some "No Parking" signs can be installed. Lt Pittman and the Streets Dept. looked at the area and determined that there were some existing restricted parking signs already approved and in the area. These signs were re-installed.

Rich Clark informed the committee that on May 15, 2021 an event will be held at Nave Marine Club. He requested that there be some temporary "No Parking" signs installed in front of the club.

Alderwoman Allport asked if there was any more movement or new information regarding the traffic study for the Locust St/Lincoln Ave. intersection. Mr. Hoffman informed Alderwoman Allport that James Elmer, the Director of Engineering, has the cost estimate for the work.
