- **LFD Personnel Attending Paramedic Classes:** They are finishing their clinical time now. Finals will be held in July—they will be all done in August
- **Probationary Firefighter Updates:** Firefighter John Roessler Jr. graduated last weekend. He did an excellent job at the Academy with exams and testing. He starts paramedic school in a month and a half. (Next Fire Academy begins August 14th)
- **Captain & Lieutenant's Promotional Exams 6-26-21:** Currently, 4 have signed up for the Captain's exam and 9 have signed up for the Lieutenant's exam.
- **ESO E-PCR Update:** Mayor Roman has signed a 12-month contract with ESO.
- **Fire Inspection Program Update:** 18 inspections have been done, with 15 requiring re-inspection. LFD currently has 5 inspectors.
