Whereas, the City of Lockport is required to hold a public hearing to provide information to the public and to consider citizen comments regarding community needs and the plan proposal prior to submitting an application for AHC funding; now, therefore, be it

Resolved, that the Common Council hereby calls for a Public Hearing whereas all interested parties shall be heard regarding the AHC program, the City's community development programs, and the proposed funding application. Such Public Hearing to be held on September 15, 2021, at 5:30 pm in the Common Council Chambers at One Locks Plaza, Lockport, New York; and be it further

Whereas, the deer population within the city limits has increased dramatically, causing significant damage to McCollum Orchards, the only farm located wholly within the city limits, with estimates of annual product loss exceeding \$10,000; and

Whereas, the New York State Department of Environmental Conservation, in recognition of this problem throughout New York State, has developed a deer-damage permit

process to reduce the number of deer within specified areas that are otherwise outside approved hunting areas and have experienced financial loss as a result; and

Whereas, the owners of McCollum Orchards have taken all necessary steps to procure the appropriate permit from the DEC for bow hunting, subject to Common Council authorization; and

Whereas, the City Code ordinarily prohibits the use of bow and arrow as a deadly weapon within the city limits, but there are no other methods for thinning the deer population that are acceptable and humane; now, therefore, be it

Resolved, that the owners of McCollum Orchards are authorized, in accordance with its DEC permit, to issue tags to bow hunters in the limits set forth in said permit, and in accordance with all other restrictions incorporated into said permit; and be it further

Resolved, that there will be no discharge of firearms authorized by this resolution in connection with any deer-hunting; and be it further

Resolved, that this authorization is limited to McCollum Orchards, and no other city residents unless and until they obtain their own DEC permits and apply to the Common Council on a case-by-case basis.

Whereas, the Lockport City Building Inspector, Planning Board and Zoning Board of Appeals anticipate receipt of several technical submissions relative to a proposed planned unit development within the city limits within the next month; and

Whereas, the nature of these submissions requires specialized legal analysis to ensure proper compliance with local, state, and federal laws that goes beyond the scope of work regularly handled by the Corporation Counsel staff; and

Whereas, the City has traditionally employed special counsel in such circumstances; and

Whereas, Resolution 040721.8 (FY 2021 Budget Supplement #1) established a Park Revitalization Program (H206) in the Capital Budget with \$275,000 in available funding; and

Whereas, the Director of Highways and Parks has compiled quotes for a concrete floor for the "Parco" pavilion north of the hardball diamond at Outwater Park, by Palladino Concrete for \$6,300; and

Whereas, the Community Pool needs concrete repairs and other repairs to limit any liabilities for trip hazards or any other hazards, to include masonry repairs to exterior walls, replacement of damaged downspouts, painting of the exterior of the building, as well as metal support posts and wood ceiling, for \$12,500; and

Whereas, Resolution 042121.8 established that pickle ball courts are on the current consensus list of improvements that should be made; and

Whereas, Rogers Park has an ice skating area, approximately 55 X 100 feet, that can double as pickle ball courts during warm weather months; and

Whereas, that can be improved by City crews excavating the area, and by adding stone and asphalt, at a cost of \$16,500; and

Whereas, the Director of Highways and Parks has requested placing removable Bollard posts at the entrances of Kibler and Grossi Parks at a cost of \$2,215.75 per quote from Reliance Foundry; now, therefore, be it

Resolved, that the City of Lockport Common Council hereby approves of the Mayor to enter into contracts with above vendors and utilize funds in the H206 capital project.
