**Comm. Morello called the meeting to order at 5:18pm**

**I. Reports Received**

- **Motion by Comm. Michel, seconded by Comm. Bates for reports received. Ayes 3**

**II. Reports Accepted**

- **Motion by Comm. Bates, seconded by Comm. Michel for reports accepted. Ayes 3**

**III. Approval of Minutes**

- **Motion by Comm. Morello, seconded by Comm. Bates to accept the minutes of the regular meeting of June 8<sup>th</sup>, 2021, and the special meeting of June 14<sup>th</sup>, 2021. Ayes 3**

**-Comm. Morello said the Fire Board will not meet in August, and the September meeting will begin at 4:30pm**

**IV. Executive Session**

- **Motion at 5:24pm by Comm. Morello to enter into executive session to discuss personnel; seconded by Comm. Bates. Ayes 3**

**-Comm. Schratz joined the meeting during the executive session**

**V. End of Executive Session**

- **Motion at 5:54pm by Comm. Schratz to exit executive session, seconded by Comm. Bates. Ayes 4**

**-Motion by Comm. Morello, seconded by Comm. Bates to instruct Chief Brady to offer a probationary position as Firefighter to Jonathan Fredrickson. Ayes 3, Nays 1 (Comm. Michel)**

**-Motion by Comm. Morello, seconded by Comm. Schratz to instruct Chief Brady to offer a probationary position as Firefighter to Sean Fisher (provided J. Fredrickson declines the offer). Ayes 4**

**VI. Review the Chief's Agenda**

- **LFD Personnel Attending Paramedic Classes: 7 took the exam on July 12<sup>th</sup> and all passed. The practical skills exam is next week, then scheduling for the NYS exams. All should be added sometime in August, giving LFD 27 paramedics on staff**
- **Probationary Firefighter Updates: Firefighter Roessler has been assigned to the 2<sup>nd</sup> Platoon. Firefighter Daigler (and the new probationary firefighter) should graduate the academy in October**
- **Captain & Lieutenant's Promotional Exams: Good turnout- awaiting scores (still awaiting the results of the March exams)**
- **ESO E-PCR Update: Capt. Scapelliti and Firefighter Burke continue to work on the program on a daily basis**
- **Fire Inspection Program Update: An ongoing program with 31 completed. 21 are up for re-inspection. Currently, 5 qualified personnel are conducting inspections**
- **Upcoming Civil Service Exams: The MTO exam will be given in October, the next Asst. Chief's and Chief's exams in December, and the next Firefighter's exam in April, 2022. The current list is certified through October, 2022, but the Fire Board can request another test be given**
