Whereas, the Common Council of the City of Lockport desires to provide funding to the Salvation Army in the amount of \$2,500.00 to provide "Code Blue" Warming Shelter services from October 1, 2021 through March 31, 2022; now, therefore, be it

Whereas, the Superintendent of Highway and Parks, as well as the City Electrician, has recommended utilizing CHIPs funding to purchase a bucket truck which will be used for maintaining City-owned street lights, as well as for regular operations of the street maintenance crew; now, therefore, be it

Resolved, that the Common Council hereby authorizes the Mayor to enter into a purchasing agreement under State bid with Altec to purchase said piece of equipment for a total of \$132,320.

Whereas, in preparation of potential insurance recoveries, the City has maintained budgetary deficits, which, in light of recent information from our insurance carrier, fall within our deductible costs and now need to be corrected; now, therefore, be it

Resolved, that the Common Council authorizes purchase orders from the Danforth Group for underground gas main repairs (\$118,439) and from Koester Associates Inc. for pump replacement work (\$30,745) to be authorized from H205, the City's Sewer Infrastructure Reserve Fund, established in Resolution 112420.6, and be it further

Resolved, that the Common Council hereby reduces the indirect cost allocation that the Sewer Fund is to expense to the General Fund by \$52,038, and be it further
