Whereas, Appendix A delineates the grades for each individual AFSCME position; and Whereas, the City acknowledges the need to maintain a strong qualified workforce; and Whereas, the City acknowledges that many qualified employees have the potential to

transfer to higher paying municipalities or in the public sector; and

Whereas, the City and the Union acknowledge the need to reorganize the grade system to reflect the actual level of expertise and qualifications of the specified positions; and

Whereas, the Union and City desire to amend and clarify the CBA through this agreement (hereinafter the "Amendment"); now, therefore, be it

Resolved, the City and the Union agree as follows:

1. There shall be the creation of a Grade 12.

2. The current grade 11 Mechanic position shall become a grade 12 position effective January 1, 2022.

3. The current grade 8 Tree Trimmer position shall become a grade 10 position effective January 1, 2022.

4. The current grade 10 Tree Crew Leader position shall become a grade 12 position effective January 1, 2022.

5. The current grade 10 Streets Crew Leader position shall become a grade 12 position effective January 1, 2022.

6. All other provisions of the CBA, not herein modified, shall remain in full force and effect.
