

**LOCKPORT PLANNING AND ZONING BOARD**

The meeting of the Lockport Planning Board was called to order at 5:00 P.M. at the Lockport Municipal Building, One Locks Plaza, Lockport, New York.

1. Joseph Taylor. 322 Hawley Street. Request for site plan approval to erect a 64' x 64' metal building situated in an I-2 Zone.

Mr. Taylor stated that he would like to build a building for sports and recreations to keep the kids busy. He said that he wants to keep the kids off the streets and give them something to do. He said that the building will be built by Parco and financed by himself. He said that he would like to have programs from 3 p.m. to 6:30 p.m. after school and on the weekends all day. He said that they won't just have sports, they would like to include arts and crafts. He said that he has spoken to a few counselors that would like to help as well.

Commissioner Tracy asked what color the building is going to be.

Mr. Taylor said that the roof will be black and the walls will be charcoal gray. He said the building will have LED box lights on it that will be on from dusk till dawn. He said that he will put up as many lights as possible. He said that he is going to install security cameras that will store video of everything.

Mr. Taylor said that he plans on landscaping with scrubs and vines. He said that he wants the building to fit into the neighborhood, to look residential.

Commissioner Tracy asked if there will be any signage on the building.

Mr. Taylor said no, not at this time.

Commissioner Roth asked if there is going to be any outdoor activities.

Mr. Taylor said that everything will be indoors. He said that he might get some picnic tables to do cookouts for the neighborhood to get to know everyone.

2. Jack Wery. 26 Market Street. Request to amend the existing approval for outdoor events in the parking lot to include alcohol sales situated in a B-2 Zone.

He said that they got a good response from the public and would like to keep going. He said that they would like to add alcohol sales. He said that Mike Molinaro is going to provide the alcohol sales.

Mr. Wery said that they are going to start doing the events every other week so that people don't burn out. He said that they are going to keep advertising and having bands. He said that they are also going to have more bathrooms on site.

Commissioner Allport asked if they are going to schedule these events opposite of the Council meetings.

Mr. Wery said that they are going to start May 4<sup>th</sup> and continue every other week from there. He said that Sal Licata is going to be doing the sound and stage for them. He said that they did great last year.

Commissioner Tracy asked how long the events are going to run.

Mr. Wery said that they are going to run from May 4<sup>th</sup> to July 22<sup>nd</sup>. He said that they will be from 5 to 8:30 p.m. He said that it is difficult to clear the parking lot out because the tenants park there until around 5.
