

STATEMENT OF CASE:

The City of Lockport Fire Department apparatus ramp on Niagara Street is a hazard to citizens and personnel entering and exiting the building. This deteriorating ramp is an ongoing issue since at least 2006 when a Health and Safety Grievance was filed in regards to the deteriorating condition of the ramp. Then again in 2019 another Health & Safety Code Violation was filed due to past repairs not holding up and creating a hazard for citizens and personnel. Over the years of these filings the ramp has been patched and repaired, but continues to get worse with larger holes and more numerous holes. These repairs are very temporary and do not hold up long, especially with rainstorms, winter snowplowing, and freezing then thawing cycles. The latest repair was using blacktop to fill in holes and cracks on the concrete ramp. These repairs have created large humps and uneven surfaces on the entire ramp. These most recent repairs have again created a tripping hazard for citizens and personnel, and have created an uneven surface for backing up apparatus into the bays. There is also a concern for citizens walking across the ramp, as there are 2 sidewalks that end on either side of the ramp.

ADJUSTMENT DESIRED:

Lockport Fire Department Local 963 would like the ramp immediately torn out and replaced with a new concrete ramp.



To whom it may concern,

On the morning of July 2, 2022, approximately 10:30 AM I was driving north on Pine St. I struck an unguarded manhole cover that was exposed during street milling and not visible in the shade of surrounding trees at the intersection of Gaffney Rd. See submitted photos. This caused 2 tires on the right side of my car to blow out due to sidewall cuts caused by this exposed manhole cover.

I called the Lockport Police Department and requested this hazard be guarded as it was potentially dangerous. They did place a cone over the manhole cover. See attached reports. Within a day or two the cone was gone. On following mornings we saw other car tires being blown by the same exposed, shadowed, and now again unguarded cover. After observing multiple cars being damaged, on July 11th I again called the Lockport Police Department to request a barrel be placed over the hazard. I also contacted Pat Schrader about the situation. Shortly thereafter a city worker placed a barrel over the hazard.

I am submitting the estimate to replace my two tires. I expect to be reimbursed. All of this is the result of the necessarily of milling Pine Street and leaving the raised unguarded, dangerous driving hazard.

RESOLUTION REQUIRED FOR NYS SMART GROWTH COMPREHENSIVE PLANNING GRANT PROGRAM APPLICATION

Whereas, the City of Lockport (City) is seeking funds from the Department of State (DOS) for a Smart Growth Comprehensive Planning Grant and intends to submit via the New York Consolidated Funding Application (CFA) for said grant; and

Whereas, the City project cost estimate for the Smart Growth Comprehensive Planning Grant Project is \$57,000; and

Whereas, the Smart Growth Comprehensive Planning Grant program through NYS Department of State (NYSDOS) is authorized to fund up to \$51,300 of the project cost; and

Whereas, Nussbaumer & Clarke, Inc. is authorized to prepare a grant application on behalf of the City via the CFA for the Smart Growth Comprehensive Planning Grant Project; and
