

On 09/02/2022 I was driving my vehicle up South Transit Rd going by Kwik Fill and hit a long cracked/damage/ bump in the road. Which caused my vehicle to bounce and slam, immediately I heard a rubbing/ grinding noise from the front end of my vehicle. I decided to go to the nearest parking lot to check and see what was damage I hit a second bump which made the sound worse. I pulled into the plaza to check my vehicle and notice it was sitting low. I got back into my vehicle to take it to the nearest repair shop (MAVIS, TIRES & BRAKES) to see if a mechanic could inspect my vehicle for damages from what had occurred. MOTION FOR WRIT OF MANDAMUS

Index No. 174016/2021

HERE NOW COMES Dana Karlson Barish, hereafter referred to as OWNER of the property at 227 Church Street, in the City of Lockport, and moves that a Writ of Mandamus be issued to the City of Lockport:

I. Jurisdiction

1. I, Dana Karlson Barish, pro se, hereby affirm under the penalties of perjury that the following statements are true, except those made on information and belief, which I believe to be true.

2. WHEREAS the OWNER has paid all property taxes and properly disputed the fees referred to in tax lien documents relating to violation of City of Lockport Code 158-17 hereafter referred to as CODE and the fees have not been adjudicated with due process as resulting from uncharged and unadjudicated criminal offenses, the OWNER finds that the Supreme Court does not have jurisdiction in this criminal matter in the manner in which it was presented to the court. To wit The Charter and Code of the City of Lockport states:

"§ C-64. Violation of ordinances; actions to restrain violation. A person violating an ordinance of the Common Council shall be guilty of a misdemeanor. The Common Council may provide in any ordinance that a violation thereof shall be punished by a fine not exceeding \$100 or by imprisonment in the county jail or penitentiary for not more than six months, or by both fine and imprisonment. Such ordinance may provide, in lieu of such fine and imprisonment, that a person guilty of a violation thereof shall pay a penalty not exceeding \$500, to be recovered in a civil action in a court of competent jurisdiction, in the name of the city. The city may maintain an action in a court of competent jurisdiction to restrain by injunction the violation of an ordinance, notwithstanding that an ordinance may provide a fine and imprisonment, or a penalty, for the violation thereof. [§ 64, L. 1911, c. 870"

The OWNER maintains that the New York State Constitution Article 1 Section 2 controls in this matter protecting a right to trial by jury in both civil and criminal matters and maintains this is a criminal matter by law.

However while accused of a misdemeanor, the OWNER has not been charged or tried in an appropriate jurisdiction for the violation of CODE that the tax lien references and the tax lien amounts have not been handed down by a criminal court as required by New York State law. The Charter and Code states that the matter is a misdemeanor and imposes substantial penalties and is thus a crime for which the OWNER demands a jury trial.

3. The OWNER disputes that the listed adminstrative fees are "delinquent tax" and such fees are not listed in the New York Real Property Tax Chapter 50-A Article 11, Title 1 Section 1102 definition of "charges" or "delinquent tax". The simple inclusion on a tax bill does not by itself make a fee subject to foreclosure proceedings and such fees are no different from refuse fees or water and sewer fees except that nothing of value has been given to OWNER exclusively in exchange for such fee. As these fees are not applicable then the total delinquest tax is null. 4. The OWNER does not recognize the CODE related to the fees in the tax lien as constitutional which shall be matters brought up at trial, specifically Code 158-17:

a. is a denial of a right to trial for a crime and penalties

b. imposes a tax unequally (69 N.H. 318, 41 A. 347 NH)

c. is not uniformly enforced

d. is unconstitutionally vague

e. requires acts that are impossible to perform

and other matters to be brought up at trial

5. As the entire Code 158-17 is unconstitutional as it contains no severence clause, the OWNER maintains that any requirements therein for process are also null and void.

If the court rules that it has jurisdiction over a criminal matter then OWNER reserves the right to further submit appropriate memoranda and affidavits and motions to support claims made in this Motion for Writ of Mandamus.

WHEREAS,

1. The court representative presiding over the Conference held in this matter on August 31, 2022, was unable to satisfactorally answer questions about the Rules of Civil Procedure controlling such Petition for Foreclosure matters but resorted to advising that the OWNER retain an attorney,

2. the OWNER is pro se,

3. a verified answer was timely submitted although its purpose was not supplied by court filings and notices,

4. it is unclear if a verified answer is subject to consideration, hearing, and ruling by the court,

5. a Motion for Writ of Mandamus must be heard by the court and should be answered by the City of Lockport,

The OWNER moves that a Writ of Mandamus be issued to the City of Lockport with the following demands by the court,

1. that the name of the OWNER be removed from the petition in this matter or the OWNER otherwise be released from judicial action,

2. that criminal accusations by the City of Lockport be filed as charges in a Criminal Court or such penalties arising out of such accusations be removed from city records or otherwise be made null and void,

3. that the City of Lockport cease and desist attempting to foreclose on properties solely on the basis of charges arising out of criminal accusations without proper adjudication.
