 - 63 ELMWOOD AVE 63 Elmwood Ave fire was led by Capt. Tim Lundquist. This was his first fire as Incident Commander.
 - Unoccupied. Relatively new owner.
 - AT same time of ELMWOOD, there was a stabbing and Chief Quagliano asked that the ambulances change "places" – and the Twin Cities Ambulance then said that they weren't going to make it.
