## Authorization for purchase of EV Charging Equipment for Pine St. Parking Lot

## RESOLUTION URGING THE STATE TO ENACT MEASURES TO PROTECT FIRST RESPONDERS AND CHILDREN FROM ACCIDENTAL ILLEGAL DRUG OVERDOSES

**WHEREAS**, in the past few years, the City of Lockport, like many other municipalities, have endured a spike in illegal opioid related overdoses and deaths; and

**WHEREAS**, often first responders are exposed to illegal opioids while responding to emergencies; and

**WHEREAS**, recently, three Lockport first responders were injured due to exposures to illegal opioids whereby emergency naloxone was administered to the first responders; and

**WHEREAS**, children have also been the victim of exposure to illegal opioids due to drug use or drug residue in their immediate vicinity; and

**WHEREAS**, some children have suffered overdoses or other injuries due to the exposure to illegal opioids; and

**WHEREAS**, first responders, children and people not using illegal opioids need to be protected from harmful and dangerous exposure to opioids, drug paraphernalia and residue; and

## NOW, THEREFORE, BE IT

**RESOLVED**, that the City of Lockport Common Council urges the New York State Legislature and Governor Kathy Hochul to enact strong legislation and criminal sanctions to curb the exposure of illegal opioid residue to first responders, children and people not using illegal opioids; and be it further

**RESOLVED**, that the City of Lockport Common Council urges Senator Rob Ortt and Assemblyman Michael Norris to sponsor legislation intended to address this very serious issue; and be it further

**RESOLVED**, that certified copies of this resolution be forwarded to Senator Rob Ortt, Assemblyman Michael Norris, Governor Kathy Hochul, and any other elected official deemed necessary and proper.

**Whereas:** The City of Lockport is a member of the Niagara County Emergency Services Mutual Aid Plan; and

**Whereas,** the City of Lockport was notified in late 2022 that it will not have ambulance operation effective February 1, 2023, as the City's need has far exceeded the local volunteer fire companies' ability to provide ambulance service to the City, which is a detriment to the citizens and visitors of the City of Lockport; and

**Whereas**, the City of Lockport Common Council hired Freed Maxick to perform an Audit on Ambulance Service which concluded that a City-run ambulance service could operate at a long-term, no net loss, to the City; and

**Whereas**, the Mayor appointed an ad hoc committee entitled "the City of Lockport Ambulance Advisory Board", that studied the need and implementation for City run Fire Department operated ambulances, and said Board recommended that the City begin operating a Fire Department operated ambulance service within the City; and

**Whereas** due to the forgoing, the prior Council called a Special Meeting held on December 19, 2022, to vote on a Resolution calling for Lockport Fire Department (LFD) to operate its own City-run ambulance service; and

**Whereas** the Resolution for said Ambulance service (Resolution No. 121922.2) passed, and LFD run ambulance service began servicing the City on February 14, 2023; and

Whereas the City was just served with a frivolous lawsuit, filed by one sitting common council member and other Petitioners, attempting to overturn that lawful vote, and to put the Citizens of Lockport in danger by immediately halting LFD run ambulance services; and

Whereas this life-saving operation being provided to the City residents is so important to the Lockport common council members, that despite the meeting and the vote of December 19, 2022; being properly administered, the Common Council wishes to reaffirm their position and again vote on LFD run ambulance service, in an effort to save taxpayers potentially tens of thousands of dollars in legal fees fighting an ill-considered and unnecessary lawsuit; and

## NOW, THEREFORE, BE IT RESOLVED THAT:

- (1) The Lockport Fire Department shall make two of the ambulances in the LFD's possession fully operational (with a third in reserve for when the other two are in repair, or not operational), including any necessary funding for the required equipment for same, required licensing and insurance;
- (2) The City shall immediately apply for a Certificate of Need for Ambulance Services; and
- (3) The City shall commence appropriate negotiations for reimbursements and billing for ambulance services and care with appropriate insurance providers; and
- (4) The FY 2023 General Fund Balance is amended as follows:
