Whereas the City of Lockport (hereinafter "local government") believes that the lack of housing for New York residents of all ages and income levels negatively impacts the future of New York State's economic growth and community well-being;

Whereas the housing crisis has negative effects at regional and local levels, we believe that every community must do their part to contribute to housing growth and benefit from the positive impacts a healthy housing market brings to communities;

Whereas we believe that supporting housing production of all kinds in our community will bring multiple benefits, including increasing housing access and choices for current and future residents, providing integrated accessible housing options that meet the needs of people with sensory and mobility disabilities, bringing economic opportunities and vitality to our communities, and allowing workers at all levels to improve their quality of life through living closer to their employment opportunities;

Whereas we believe that evidence showing that infill development that reduces sprawl and supports walkable communities has significant environmental and public health benefits; and

071024.9 GLDC's NYMS Grant Application By Alderman Craig: Whereas the Greater Lockport Development Corporation (GLDC), conducted a public "Request for Projects," from City of Lockport commercial property owners who are interested in pursuing a renovation project utilizing New York State grant funds; and

Whereas the purpose of which was to allow for an open, fair, and public project selection process, for consideration for such State-funded grant programs; and

Whereas, the GLDC received three eligible submissions on behalf of city property owners to develop a city-wide project list and prioritize potential projects to select from as various grant opportunities become available through the state; and

Whereas the NYS Office of Homes and Community Renewal is offering a New York Main Street Grant program through the State's Consolidated Funding Application, including a "Downtown Stabilization" grant used "to identify or mitigate risks associated with hazardous materials; or remove obstacles to future redevelopment; to assist with environmental remediation and associated construction costs; as well as other innovative approaches to stabilizing and developing downtown, mixed-use buildings; and

Whereas Tru Commercial Development submitted 58 Main Street for consideration of grant funding to pursue Phase I of a mixed-use redevelopment project; and

Whereas the Director of Planning and Development and GLDC staff have reviewed the New York Main Street "Downtown Stabilization" program and the submissions received and have determined that the proposed project for 58 Main Street is the most applicable and competitive project the Lockport community can put forth to be awarded funded and are requesting to submit a CFA application to the NYS Office of Homes and Community Renewal for an approximately \$350,000 grant; and

Whereas Tru Commercial Development, if awarded funding, has committed to the 25% match requirement of approximately \$115,000 and to completing the project;

Now therefore let it be

Resolved that pursuant to their request, the Greater Lockport Development Corporation is hereby authorized to submit a New York Main Street grant through the 2024 NYS Consolidated Funding Application on behalf of a business and property owner in the City of Lockport, as identified by the GLDC, for the purpose of rehabilitation and renovation;







- 11. Replace all drip edge metal with new metal edge per code. If required, form fascia extenders out of metal flat stock to accommodate blocking height.
- 12. Install new .040 aluminum gutter and downspout.

13. After roof system is cured, aluminum coat field and flashings.

- Remove all insulation and existing EPDM roof system down to the concrete deck.
- · Remove all existing edge and fascia metal.

Insulation:

Provide new 1/8" tapered R30 insulation plan pitched to the drip edge.

Perimeter Blocking:

Base Sheet Installation:

Install copper pitch box with rain collar at pipe penetration.

Drip Edge Replacement:

- Replace all drip edge metal with new metal edge per code.
- Form fascia extenders out of metal flat stock to accommodate blocking height if required.

Gutter and Downspout:

Install new .040 aluminum gutter and downspout.

Aluminum Coating:

After the roof system is cured, apply an aluminum coat to the field and flashings.

6. The tour began at the ticket office of Lockport Cave & Underground Boat Ride, which is located at 5 Gooding St., Lockport, New York 14094.

 As part of the tour, guests attended a "Boat Ride" in furtherance of the historical tour.

8. It was Claimant's understanding that the boat ride would venture into the cave, and once at the end, would reverse and return back to the starting point.

9. On June 12, 2023, during the boating portion of the tour, at approximately 11:30 a.m., the boat became unbalanced and capsized, sending the Claimant and Claimant's fellow passengers into the freezing water below.

10. Upon information and belief, the incident herein described, and the resultant damages sustained were caused as a result of the negligence, carelessness, recklessness, and deliberate indifference on the part of the agents, servants, and/or employees of the City of Lockport. These acts include, but are not limited to, the following:

a. Negligent supervision;

b. Negligent failure to recognize a known danger;

Negligent failure to take proper measures to correct the danger;

d. Negligent failure to inspect the tour boat;

e. Negligent failure to license the tour boat;

f. Negligently failing to prevent injuries;

g. The Respondents were otherwise negligent.

WATER RECLAMATION PROCESS AND CONTROL ADMINISTRATOR

Distinguishing Features of the Class: This is an important supervisory and technical position involving responsibility for the safe and efficient operation and maintenance of an Activated Sludge (Type A) Wastewater Treatment Plant in accordance with and adherence to all Federal, State, County, and Municipal Laws. Supervision is received from the Mayor. Supervision is exercised over all subordinate Wastewater Treatment Plant personnel. Does related work as required.

Typical Work Activities: (Illustrative Only)

Assists with the administration of all applicable laws and regulations as they pertain to the operation of a NYSDEC rated Wastewater Treatment Facility;


