- <u>Tech Grant</u> was applied for and was approved through the state for \$210K – ear marked for the items requested. Every patrol car will have a computer; detective interview room will be updated; DRONE program will begin (Road patrol supervisor and QRT Team will have a drone as well); There will be assistance for LPD in supporting the LFD. (Would be able to find the hotspots in a house on fire).
 - This year all the requests that were made were given to the requesting departments.

- \$67K was used to purchase 35 new vests they are a ew bullet proof vests, they have been upgraded to block a rifle round.
 (They are also good for ten years). Of the \$67K \$19K will come back from the state, purchased first then reimbursed for the purchase).
- Consortium Meeting with Sherriff's Office Chief Abbott and Mayor attended with other participants from other municipalities and schools along with local community members. There has been a great deal of expressed concern about the process of bail reform and the impact on the local communities.
