#### Calls for Service

- Blotters filed: 1,541
  - Average of 52 calls for service a day.
  - In September of 2023, there were 1,522 calls for service made to LPD.
  - This is an increase in call volume.

## Case Reports

- Case Reports filed: 126
  - Average of 4 crimes reported per day.
  - In September of 2023, 210 crimes were reported to LPD.
  - This is a decrease in the number of crimes reported to LPD.

## Arrests made

- Custodial Arrests: 33
- Average of less than 2 persons arrested per day.
  - In September of 2023, LPD made 59 custodial arrests.
  - This is a decrease in the number of custodial arrests made.
