Chief's Agenda:

- CompStat Report: (you can highlight the items you would like, or I can review and add)
  - Blotters filed: 994
    - Average of 33 calls for service a day.
    - In December of 2023, there were 1,033 calls for service made to LPD.
    - This is a decrease in call volume.
  - Case Reports filed: 94
    - Average of 3 crimes reported per day.
    - In December of 2023, 101 crimes were reported to LPD.
    - This is a decrease in the number of crimes reported to LPD.
  - Custodial Arrests: 26
    - Average of under 1 persons arrested per day.
    - In December of 2023, LPD made 54 custodial arrests.
    - This is a decrease in the number of custodial arrests made.

- YTD Calls For Service
  - Blotters: 17,098
  - Case: 1,462
  - Arrests: 490

Some items to note for the coming year:

1. Police exam results are in and 28 of the 32 passed. The agility test will be next and then the background checks.
2. The City is looking to hire 3 policemen this year. Tentative date for interviews is March 2025.
