On June 2, Central Niagara Catholic Family of Parishes celebrated the Solemnity of the Most Holy Body and Blood of Christ with a unifying procession through Lockport's main streets from St. John the Baptist Parish to All Saints. 















Proposed Route for 2025 Eucharistic Procession (Central Niagara Catholic Family of Parishes)
