Adoption of 2024 City of Lockport Comprehensive Plan & Local Law No. 1 of 2025, A Local Law Repealing and Replacing the City of Lockport Zoning Code (Chapter 190) and Official Zoning Map

Whereas, the Common Council of the City of Lockport (hereinafter "Common Council") engaged a consultant team to direct concurrent updates to the City of Lockport Zoning Code (Chapter 190) and the City of Lockport's 1998 Comprehensive Plan, and

Whereas, the City of Lockport formed a Comprehensive Plan Committee and a Rezoning Committee to guide the creation of a revised Comprehensive Plan and Zoning Code respectively, which has culminated in a final draft of the City of Lockport Comprehensive Plan and Zoning Code and Official Zoning Map, and

Whereas, the final draft of the City of Lockport Comprehensive Plan and Zoning Code and Official Zoning Map have been fully reviewed by the City of Lockport Planning Board and the Niagara County Planning Board, and a public hearing has been held to accept public comments regarding the matter, and

Whereas, the Common Council, on the advice of the Corporation Counsel and its consultant team, intends to act as lead agency with respect to the action for the purposes of conducting a review under the State Environmental Quality Review Act and the implementing regulations of the New York State Department of Environmental Conservation adopted thereunder (6 NYCRR Part 617) (hereinafter collectively referred to as "SEQRA") to all involved and interested agencies, and has received no objection to its serving as lead agency, and

Whereas, a Full Environmental Assessment Form, parts 1, 2 and 3, was prepared by Colliers Engineering & Design, and was circulated to involved agencies for input pursuant to SEQRA, and

Whereas, the Common Council has considered the action and reviewed the EAF and all comments received from involved or interested agencies, in light of the criteria set forth in SEQRA in order to determine whether the action will have a significant effect on the environment, now therefore be it

Resolved, that the City of Lockport Common Council hereby declares itself lead agency for the

purposes of SEQRA review of the action, and be it further

**Resolved**, that based upon the information set forth in the EAF, and for reasons more fully set forth in parts 2 and 3 of the EAF, the Common Council hereby determines that there will be no significant environmental impacts with regard to the action, and hereby adopts and issues the attached Negative Declaration under SEQRA with respect thereto, and be it further

Resolved, that the Mayor be, and hereby is, authorized to execute any necessary documents in

conjunction hereto.

Whereas, in January of 2021, the Common Council of the City of Lockport (hereinafter, "Common Council") engaged a consultant team to direct concurrent updates to the City Zoning Code (Chapter 190) and 1998 Comprehensive Plan; and

Whereas, in the spring of 2021, a Comprehensive Plan Committee (hereinafter, "Committee") was formed to revise the 1998 Comprehensive Plan in addition to a Rezoning Committee to guide the zoning code update. This Committee consisted of residents and representatives from the City's Building and Community Development Departments, review boards, school board, GLDC, and Niagara County; and

Whereas, the ongoing comprehensive plan and zoning code update process, under the direction of the Committee, resulted in a Draft Comprehensive Plan (hereinafter, "Draft Plan"); and

Whereas, a public hearing was held by the Committee for the review of the Draft Plan in Council Chambers at the Lockport municipal building, 1 Locks Plaza, Lockport, on August 28, 2023, at 6:00 pm; at which the Committee heard all testimony offered in favor or opposition to the Draft Plan; and

Whereas, the Committee determined that it is in the best interest of the City to recommend the Draft Plan to the Common Council for consideration for adoption, recognizing that it not only identifies a unified community vision, but also provides an action-oriented framework for the achievement of such vision as well as future land use recommendations and a place-making plan guiding the concurrent zoning code update effort; and

Whereas, At the regular meeting of the Lockport Planning Board held on March 3, 2025, the Planning Board reviewed the proposed Comprehensive Plan and revised Zoning Code as well as a review of the Waterfront Consistency Review checklist. The Board determined that the Waterfront Consistency Review Checklist is consistent with the Local Waterfront Revitalization Program policies of the City of Lockport outlined in chapter §187-5. the Planning Board determined that it is in the best interest of the City to recommend the Draft Plan and Zoning Code Update to the Common Council for consideration for adoption with noted amendments; and

Whereas, a revised Draft Plan was prepared for consideration by the Common Council, dated January 17, 2024, which incorporated feedback from the Planning Board as well as necessary updates to maintain alignment of the Draft Plan with the concurrently developed Draft Zoning Code (Chapter 190) and zoning map; and

Whereas, the City of Lockport Common Council held a public hearing on March 12th, 2025 at 6:00 PM in City Hall located at One Lock's Plaza, Lockport, NY 14094, hearing all public comment in favor and/or in opposition to the proposed Comprehensive Plan Update and concurrent Zoning Code (Chapter 190) amendment; and

Whereas, the Common Council during the aforementioned public hearing issued a negative SEQRA declaration for the adoption of the 2024 Comprehensive Plan Update and Zoning Code (Chapter 190) amendment, considered as a joint action for the purposes of SEQRA; and

Whereas, the Common Council determined that it is in agreement with the findings and recommendations of the Committee and Planning Board, recognizing that it is in the best interest of the City to adopt the Draft Plan as it provides a well-considered foundation for future decision-making and further supports the proposed concurrent amendment to the City's Zoning Code (Chapter 190) and Zoning Map;

Now, therefore, be it resolved, that the Common Council of the City of Lockport hereby adopts the 2024 Comprehensive Plan and recognizes it as an official update to the City of Lockport 1998 Comprehensive Plan.

#### Local Law 1 of 2025

A LOCAL LAW TO AMEND THE CODE OF THE CITY OF LOCKPORT BY DELETING AND REPEALING CHAPTER 190 THEREOF, ZONING, AND REPLACING IT WITH A NEW CHAPTER 190 TO BE ENTITLED "ZONING": and

Be it further resolved, that a copy of Local Law 1 of 2025 in its entirety be posted on the City of Lockport Website and that a notice of adoption be published once in the Lockport Union Sun & Journal, a newspaper regularly published and having general circulation in the City, and posted as provided by law; and

of 2025 with the Secretary of State
