**Resolved** that the Mayor and City Clerk be authorized to issue orders in favor of the claimants for payrolls, bills and services to be paid on September 11th, 2025.

By Alderman Kirchberger:

**Whereas** the Common Council of the City of Lockport previously approved the request to hold the Locktoberfest on 9.27.2025 including certain designated road closures; and

**Whereas** the event organizers have since requested an additional road closure of Ontario Street in order to accommodate a larger number vendors than originally planned; and

**Whereas** the City of Lockport recognizes the importance of ensuring public safety and smooth traffic control during this community event;

**Now, therefore, be it resolved** that the Mayor and Common Council of the City of Lockport hereby approve the additional closure of Ontario Street during the hours of 10am-5pm on September 27<sup>th</sup>, for Locktoberfest:

**Be it further resolved** that the City of Lockport Police Department, Department of Public Works, and any other necessary departments are authorized to coordinate with event organizers to implement the closure and ensure proper traffic and safety measures are in place.

By Alderman Devine:

**Whereas** the City of Lockport (City) is seeking a grant for a Lead Service Line Replacement Project and intends to submit via the Environmental Facilities Corporation for funding to the New York Water Infrastructure Improvement Act (WIIA); and

**Whereas** the City project cost estimate for the Lead Service Line Replacement Project is \$19,880,625; and

**Whereas** the WIIA through NYS Environmental Facilities Corporation (NYSEFC) is authorized to fund up to a maximum of \$5,000,000 of the total project costs.

**Now, therefore, be it:**

**Resolved** that the City authorizes and appropriates a minimum of \$14,880,625 local match as required by the Water Infrastructure Improvement Act (WIIA). The maximum local share appropriated shall not exceed \$14,880,625, subject to receipt of a WIIA grant and available funding. The total estimated maximum grant is \$5,000,000. The Mayor may increase this local match through the use of in-kind services other eligible funding without further approval from the City.

#### **091025.5**

By Alderman Devine:

**Whereas** the City of Lockport (City) desires to replace lead water service lines and is seeking grant funding to support the project, which will require the preparation of detailed engineering plans and specifications; and

**Whereas** Nussbaumer & Clarke, Inc. furnished a proposal to provide engineering design, bidding support, construction administration, inspection, and grant administration support as needed for the Project;

**Now, therefore, be it:**

**Resolved** that the Mayor is authorized to execute a professional services agreement with Nussbaumer & Clarke, Inc., for a fee not to exceed \$2,593,125 for engineering design, bidding support, construction administration, inspection, and grant administration related to the WIIA Lead Service Line Replacement Project, contingent upon receipt of grant funding and in accordance with the City procurement process.
